ACES IDIQ STATEMENT OF WORK

The purpose of the ACES IDIQ is to provide technical assistance and advisory services, training, and direct program implementation to support host country good governance, transparency, and accountability. The IDIQ supports the integration of good governance into programs across USAID’s development portfolio, such as health, environment, and economic growth. This means applying DRG principles and practices to address obstacles in other sectors, thereby improving overall development outcomes. For example, good governance can be advanced by strengthening DRG principles in the delivery of services in the water sector, environmental and land management, and energy supply and utilization, areas where ECODIT has proven technical expertise.

The ACES IDIQ can be used by USAID OUs in Washington and in countries in all stages of political development, from those experiencing conflict or fragility to strong performers. Activities under the IDIQ fall within one or more of the following technical areas (TAs): (a) Good Governance and Anti-Corruption; (b) Strengthening the Legislative Function/Legal Framework; (c) Decentralization and Local Governance; (d) Rule of Law and Security Sector Reform; and (e) Strengthening Oversight Mechanisms.

Small Business Set-Aside RFTOPs under the ACES IDIQ

Small Business Reserve: All task orders (TOs) issued under the ACES IDIQ greater than \$3,500 but less than or equal to \$5,000,000.00 must be competed first with any category of small or small disadvantaged business contract holders.

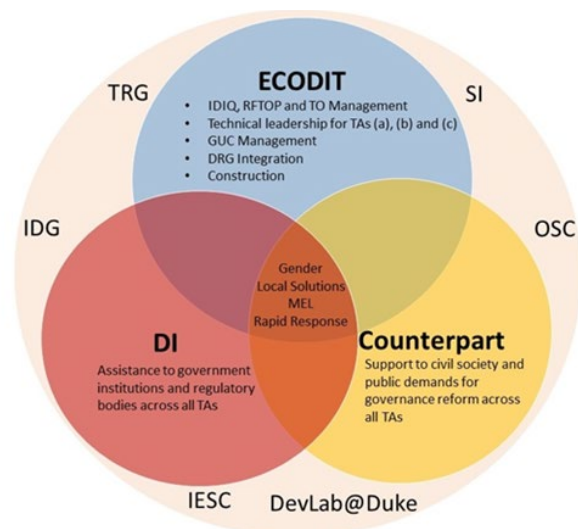
Small Business Exception to Fair Opportunity: USAID may directly place TOs with any category of small or small disadvantaged business that received one of the IDIQs awarded from the solicitation. Upon review of the corporate capability information of small business holders provided by the IDIQ COR, the TOCOR can either recommend to the TOCO one of the contractors for award or, if corporate capability is equal, the TOCOR will follow the appropriate RFTOP procedures of the IDIQ for small business set-asides. The TOCO is responsible for final selection, negotiation, and Task Order award. **The \$5,000,000.00 threshold does not apply when using the small business exception and fair opportunity procedures.**

USAID Liberia Land Management Activity (\$9.4M, 2021-2025)

Implementer: ECODIT

The USAID Liberia Land Management Activity is advancing effective and inclusive management of communal land through land tenure processes and promoting the formalization of land rights in Liberia, with special consideration for customary land rights and the rights of women, youth, and marginalized groups. Activities include building the capacity of the Liberia Land Authority, civil society, and the private sector to support communities to secure land rights; facilitating the establishment and implementation of land use plans; developing the leadership capabilities of women, youth, persons with disabilities, and other marginalized groups; engaging traditional leaders and men for improved and peaceful power-sharing; and promoting alternative dispute resolution for land disputes.

USAID Zimbabwe Resilience through Accelerating New Community-based Holistic Outcomes for Resource Sustainability (Resilience ANCHORS) Activity (\$19M, 2020-2025)

Implementer: ECODIT

The USAID Zimbabwe Resilience ANCHORS Activity is building the capacity of local partners and communities on sustainable natural resources governance to safeguard biodiversity and build community resilience. The project is empowering Zimbabwean communities to develop selected landscapes into “resilience anchors” and reduce their vulnerability to climatic shocks and economic stresses. ECODIT is working with communities, the private sector, civil society, and local government bodies to achieve these goals, drawing on its extensive experience in community and private sector engagement and natural resource governance.

USAID Lebanon Diverting Waste by Encouraging Reuse and Recycling (DAWERR) Activity (\$15M, 2020-2025)

Implementer: ECODIT

The USAID DAWERR Activity is working with municipalities, local communities, and the private sector to implement integrated solid waste management solutions for municipalities and unions of municipalities. The Activity employs innovative co-creation and solution identification approaches, engaging national and local governments, communities, youth, civil society, and the private sector. The results will be improved health and social welfare and expanded economic horizons for the people of Lebanon.

USAID Cambodia Green Future Activity (CGFA) (\$5M, 2019-2024)

Implementer: ECODIT

The USAID CGFA is a five-year project aimed at mobilizing communities, especially youth, to conserve biodiversity and protect natural resources. The CGFA team employs best practices in community engagement and SBCC to increase awareness and catalyze action via strategic campaigns in social media, radio, television, community events, and other methods. This includes a large grants management component, in which the project supports local youth organizations to take part in community outreach around natural resource management.

USAID Vietnam Green Annamites Activity (VNGA) (\$24M, 2016-2021)

Implementer: ECODIT

The USAID VNGA worked with provincial government bodies in Vietnam to help them better monitor and manage natural resources and enforce environmental laws; supported forest-dependent communities to engage in sustainable alternative livelihoods through a robust grants program; established carbon markets; and facilitated partnerships with the private sector. The project laid the groundwork for Vietnamese governments, communities, and businesses to continue working together to protect Vietnam’s natural resources. Accomplishments included reducing greenhouse gas emissions by over 11.6 million metric tons of carbon dioxide equivalent, boosting incomes for more than 15,000 people, and mobilizing more than \$59 million in private sector funding for the environment—nearly triple the Activity’s initial target.

USAID Support for the Urban Policy (SOUP) Project (\$1.3M, 2015-2018)

Implementer: ECODIT

The USAID SOUP Project supported USAID’s urban programming through training, program evaluations, and CKM. Accomplishments included delivering a training workshop for USAID staff members on Integration and Evidence for Urban Programming; designing and developing the *UrbanLinks* (<https://urban-links.org/>) platform to improve the management of knowledge in the urban sphere; supporting high-level events; producing photo essays, blog posts, case studies, a gender analysis, and infographics on urban issues; and conducting an assessment for USAID Bosnia and Herzegovina to prioritize areas for assistance focusing on sustainable energy in urban areas.

USAID Resilient Governance in Niger (RGN, \$19M, 2021-2026)

Implementer: Counterpart International

The USAID RGN project works to enhance government officials’ understanding of their responsibilities for communal governance through a focus on peer learning and a collaboration to resolve local problems; build the ability of communes to carry out their core functions through action-focused capacity development, peer-to-peer exchanges, and mentoring; promote awareness and confidence building among citizens; and support the strengthening of Citizen Monitoring Committees, issue-driven coalitions, and learnings and advocacy networks.

USAID/Timor-Leste NGO Advocacy for Good Governance Activity (\$9.5M, 2020-2025)

Implementer: Counterpart International

Through this initiative, CI is strengthening the organizational, research, networking, and financial capacity for a cohort of Timorese NGOs to provide increased evidence-based, responsive, and sustainable advocacy services on behalf of citizens. To realize this goal, the Activity focuses on four objectives: 1) strengthening NGO organizational capacity; 2) improving advocacy, research, analysis, and networking capacities for better response to constituents; 3) fostering more diverse and regular revenue streams; and 4) promoting an enabling environment that fosters independent NGOs.

USAID El Salvador Strength in Diversity (*Diversidad en Movimiento*) (\$900k, 2021-2023)

Implementer: Counterpart International

Diversidad en Movimiento in El Salvador directly responds to the need to strengthen the LGBTQI+ movement's ability to more effectively and collectively express, communicate, and defend the common human rights interests of the Salvadoran LGBTQI+ population. The project is engaging and strengthening the capacities of lesbians, queer woman, and LGBTQI+ emerging leaders and groups currently underrepresented in the movement, as well as enhancing the organizational capacity of the Salvadoran LGBTI Federation.

USAID Bangladesh Promoting Advocacy and Rights (PAR, \$6.9M, 2018-2023)

Implementer: Counterpart International

PAR works to strengthen the enabling environment for sustained civil society institutions advancing democratic governance and citizen participation in Bangladesh. Through the project, Counterpart created a living Political Economy Analysis and Gender Analysis that informs the training and technical assistance provided to Bangladeshi civil society, media, academia, and government officials. In December 2019, PAR launched the Online Advocacy Toolbox, a multi-function platform that serves as a dynamic repository for information, tools, and training materials based on best practices in advocacy in Bangladesh and internationally; a discussion platform for bridging the geographic divide for collaboration between CSOs across Bangladesh; and a showcase of success stories and advocacy initiatives across the country. PAR also conducted basic and mid-level research trainings for 25 district-level CSOs to give participants deeper understanding and knowledge needed to draft well-researched reports discussing the issues on which their organizations focus.

USAID El Salvador Rights and Dignity Project (\$15M, 2017-2022)

Implementer: Counterpart International

The Rights and Dignity Project works to strengthen governmental and non-governmental human rights protection systems in El Salvador. The project is enhancing El Salvador's human rights systems with an emphasis on security, policing, and anti-discrimination by increasing constructive engagement among governmental and non-governmental actors, increasing the effectiveness of human rights organizations to advocate for justice, improving the ability for the government to respond, reducing discrimination against vulnerable groups, and improving access to services for victims of abuses.

USAID Guatemala Participacion Civica (\$25M, 2016-2020)

Implementer: Counterpart International

The USAID Participacion Civica project strengthened and developed the capacity of CSOs and government officials in Guatemala to play a more effective role in addressing accountability, transparency, and anti-corruption related issues. Counterpart trained CSO representatives on transparency and anti-corruption measures; provided capacity building to CSOs and local government organizations on organizational development, sustainability, and transparency; and established and trained the CSO Network for Open Government to strengthen civil society's ability to monitor and evaluate government accountability and transparency.

USAID/Liberia Elections and Democracy Activity (\$16M, 2021-2026)

Implementer: Democracy International

Through this activity, DI mobilizes new political leaders and enhances civic participation of informed citizens while ensuring locally owned, inclusive development and democratization in Liberia. DI is building leadership skills and supporting new political aspirants to deploy platforms that appeal to citizens and mobilize Liberians to participate

in grassroots and national political processes; applying Social and Behavioral Science (SBS) insights to understand what predictably shapes real behavior and “nudge” citizens to move from knowledge to civic action; and supporting and catalyzing locally driven efforts by Liberian CSOs and government bodies.

USAID Jamaica Positive Pathways (\$15.4M, 2020-2025)

Implementer: Democracy International

Through USAID Positive Pathways, DI support community-based partnerships to prevent youth violence and support citizen security. DI's interventions prioritize leveraging and coordinating existing community violence prevention resources in Jamaica, supporting local initiatives and strengths using cutting-edge social and behavioral science approaches, working with the private sector to promote opportunities for youth, and encouraging Jamaican-led, Jamaican-owned activities. Using a Positive Youth Development approach, Positive Pathways focuses on interventions with youth and their families to build emotional resilience, invaluable life skills, and economic opportunities.

USAID/DFID Bangladesh Strengthening Political Landscape (SPL) Program (\$28.4, 2017-2024)

Implementer: Democracy International

SPL works to build political party capacity and strengthen relationships between parties and constituents while reducing political violence. Through the project, DI supports political party activists and politically active citizens across the country to develop the skills and knowledge to engage in decision making and gradually internalize inclusion and best practices into party structures at all levels; and support political party activists and politically active citizens to develop the skills to engage constructively to mitigate the effects of conflict. SPL works to enhance the internal democratic structures of Bangladesh's political parties, foster more inclusive and representative leadership, improve the parties' capacities to understand the needs of their constituents, and more effectively reach marginalized women and youth.

USAID El Salvador Municipal Governance Program (MGP, \$1.3M, 2017-2022)

Implementer: Democracy International

USAID MGP works to enhance decentralization efforts and strengthen local government in El Salvador in order to increase security and development. DI is creating a performance monitoring and evaluation matrix for the project in order to track the program's progress against both standard and program-specific indicators. DI will conduct political economy analyses (PEAs) in order to understand the contextual factors affecting decentralization in El Salvador, which includes identifying the most pertinent stakeholders involved in the decentralization process. These PEAs will enhance DI's method for collecting and measuring MGP data.

USAID Civic Spaces/ Illuminating New Solutions and Programmatic Innovations for Resilient Spaces (INSPIRES) (Internews, \$1.637M, 2018-2022)

Implementer: DevLab@Duke

Through INSPIRES, DevLab@Duke is working to generate an early warning system to alert stakeholders in the DRG sector of encroachments on civil society and democratic backsliding. Activities include harnessing the knowledge offered by machine learning and big data to forecast troubled civic spaces; building and integrating a multi-country bimonthly survey of in-country civil society experts; returning machine learning forecasts on civic spaces and the expert survey results back to local actors in order to help build their resilience; and relying on the forecasting tool to pilot innovative, cross-sectoral, context-driven programmatic interventions that support the creation of new coalitions and initiatives to protect civic space.

USAID Cambodia Solid Waste Accountability Platform (SWAP) (Triangle Environmental, \$328K, 2019-2022)

Implementer: DevLab@Duke

For the USAID SWAP, DevLab@Duke is working to increase government and service provider responsiveness in the waste services sector in urban Cambodia. Through SWAP, DevLab and its partners are designing an app that allows users to post issues with waste service provision and allows government and service providers to respond to these complaints in real time.

USAID Moldova Financial Sector Transparency Activity (FSTA) (\$8.1M, 2019-2022)

Implementer: International Development Group

Through USAID FSTA, IDG is supporting the Government of Moldova's commitment to strengthen the financial sector and improve its fiscal/budgetary transparency. FSTA improves financial sector transparency, accountability, stability, and resilience by strengthening the capacities of the National Bank of Moldova (NBM), the Moldova Central Securities Depository and the Moldova National Commission for Financial Markets to combat corruption and financial crimes. FSTA supports the monitoring of shareholder transparency and systemic money laundering in the banking sector by automating shareholder registry and enhancing the efficiency and reliability of the securities settlement and registry infrastructure.

USAID Support Planning, Administration and Oversight of the Venezuela Interim Government (SVIG) Project (\$7.7M, 2020 – 2022)

Implementer: International Development Group

For the SVIG project, IDG provides the Venezuelan Interim Government with capacity building services to improve its legislative, legal, communication, and administrative functions effectively. The project seeks to establish public financial management systems to ensure effective and efficient standards of financial accountability and transparency are maintained. SVIG also provides technical assistance to the interim government to effectively manage resources from different donors and international financial institutions. IDG has developed numerous public financial management processes and procedures under SVIG to ensure the Venezuelan government can manage expenditures while accounting for budgeting, revenue administration, anti-money laundering, and asset recovery in an ethical manner.

USAID Tanzania Enabling Growth through Investment and Enterprise (ENGINE, \$20.2M, 2015 – 2020)

Implementer: International Executive Service Corps

For the USAID ENGINE project, IESC supported local government authorities in the sub-national implementation of national policies and facilitated a comprehensive policy review process at the local level, resulting in 27 new policies and 364 policy recommendations for more streamlined systems that better guide businesses. ENGINE also enhanced transparency and accountability within governments by increasing public-private dialogue that affects policy reform decisions. IESC created and introduced two innovative tools for local governments to reform the local and rural business enabling environment: the Local Government Authority Competitive Index, a framework to develop baseline data and measure business enabling environment and pro-growth policies at the district level, and the Policy Prioritization Tool. Together, these tools enable local governments to assess the competitive business environment and provide guidance and support to re-align policy and regulations.

USAID Assistance in Building Afghanistan by Developing Enterprises Program (ABADE, \$105M, 2012-2018)

Implementer: International Executive Service Corps

To increase domestic revenue mobilization and local taxes, IESC worked with local governments to reduce regulatory and procedural barriers in the way of business growth and job creation and to develop effective local economic development strategies. Under ABADE, IESC worked with both the national and local governments and trained/mentored government officials in identifying and reducing regulatory and procedural barriers that impede competitiveness and foster job creation.

USAID Iraq Governance Performance and Accountability (IGPA) Project (\$3.3M, 2017 – 2022)

Implementer: Overseas Strategic Consulting

Through USAID IGPA, OSC is increasing citizen participation and public outreach to advance effective, accountable, and transparent governance. OSC trains provincial government staff on effective citizen participation and public outreach mechanisms and supports the development of locally customized communication and outreach strategies to increase citizen participation in provincial budget development, service delivery outcomes, and investment priorities. OSC provides training to provincial government staff and CSOs on using social media, hotlines, open-source phone apps, and face-to-face meetings to enhance citizen consultation and engagement.

USAID Guatemala Security and Justice Sector Reform Project (SJSRP, \$1.2M, 2012-2017)

Implementer: Overseas Strategic Consulting

For the USAID SJSRP, to promote civic engagement, OSC developed the capacity of the security and justice sector for external communications and public outreach. After conducting a communications assessment, OSC launched an inter-agency working group to foster dialogue and strengthen the coordination of communications activities, including joint statements and information campaigns. OSC's capacity building efforts included strategies to improve engagement with CSOs to promote a culture of citizenship, increase government transparency, and encourage government oversight.

USAID Democracy, Human Rights, and Governance Learning, Evaluation, and Research (DRG-LER I, \$8.8M, 2013-2018) and its follow-on LER II (\$15M, 2018-2023)

Implementer: Social Impact

For DRG-LER and its follow on LER II, SI works in partnership with USAID's DRG Center to provide a fast, flexible mechanism to efficiently and effectively gather evidence-based research and data on the impact of DRG activities to assist with decision making. SI contributes to the knowledge base of what works and does not work in the DRG sector by conducting a range of rigorous assessments, evaluations, and other research globally. These assessments provide the US government and other stakeholders with timely, solid evidence on impact and costs as needed for decisionmaking about DRG foreign assistance intervention expansion.

USAID/Lebanon Performance Management and Support Program (PMSPL II, \$24.7M, 2015-2021)

Implementer: Social Impact

For PMSPL II, SI provided ongoing technical assistance to USAID/Lebanon and its implementing partners (IPs), augmenting their capacities to manage for results, and sharing a common results agenda that fostered mutual accountability, transparency, and program learning. The project supported the development and implementation of the Mission PMP and CDCS and assisted IPs in developing and implementing their MEL. PMSPL has implemented nine project design support activities and 25 evaluations and assessments, conducted seven data quality assessments, and provided maps and GIS support to facilitate evidence-based decision-making.

USAID Communications, Evidence, and Learning (CEL) Project (\$30M, 2018-2023)

Implementer: TRG (prime) and ECODIT (sub)

The USAID CEL Project supports the Agency's Office of Land and Urban (LU) to create, expand, and disseminate evidence-based knowledge about land tenure, property rights, and resource governance, as well as urban development, urban-based programming, and sustainable cities. ECODIT is a core member of the consortium led by TRG. CEL conducts activities such as impact and project evaluations, scientific research, assessments, pilots of new technologies, communications, outreach, and knowledge management. Project outputs inform USAID program design and implementation, M&E, policy decisions, and optimize resources to advance USAID's core development objectives.

USAID Africa LEAD II (\$2.9M, 2015-2021)

Implementer: TRG

For Africa LEAD II, TRG supported the development of curricula and mentoring of training advisers, including revisions to the Champions for Change (C4C) leadership training that was successfully offered to over 1,800 practitioners under Africa Lead I, as well as members of Parliament in Tanzania, Governors in Kenya, and Ministry of Agriculture staff. TRG also co-designed a C4C community mobilization training program for community-based organizations in Tanzania that focused on the engagement and empowerment of women and youth to contribute to food security and an Advanced Training of Trainers program for 24 Africa Lead II training facilitators from West and East Africa.
